Program requirements and notes

In order to graduate you must:

- Successfully complete 384 units as outlined in the Program Structure
- Complete 80 days Supervised Professional Experience, completed as full-time blocks, most of which must be completed in Queensland schools
- Complete 25 days of environmental fieldwork on K'gari and other natural environments on the Sunshine Coast
- It is recommended that students obtain first aid and CPR certificates
- Successfully complete the Literacy and Numeracy Test for Initial Teacher Education students. For more information on this Government initiative please visit the Students First website. - Professional Experience courses (EDU328, EDU424, EDU426) should not be completed in the same semester as a course from a major or extended minor. All courses studied concurrently with a Professional Experience course should be EDU coded

Program notes

- EDU415 *MUST* be studied in your final semester of study with your final Professional Experience
- Completing this program within the specified (full-time) duration is based on studying 48 unit points per semester (normally 4 courses) and following the recommended study sequence
- The unit value of all courses is 12 units unless otherwise specified
- It is each student's responsibility to enrol correctly according to your course requisites, program rules and requirements and be aware of the academic calendar dates
- Cross-institutional study is not permitted for the education (EDU) coded courses and SCS203 Introduction to Aboriginal and Torres Strait Islander Education in the Bachelor of Education (Secondary) / Bachelor of Recreation and Outdoor Environmental Studies
- Courses within this program are assessed using a variety of assessment methods which may include essays, seminar presentations, reports, in-class tests and examinations
- Only a full-time study option is available to international students on a Student Visa
- Students will need to be aware of the physical components and location requirements of the program. If you have a disability, medical condition or any concerns that may affect your potential participation in some of the practical components of the program, you are invited to discuss your options with the program coordinator

WIL notes

In order to commence Professional Experience (PEX) placement you must:

- Obtain a Blue Card (or link your existing Blue Card to USC) prior to commencing supervised professional experience. Applications should be submitted at least 12 weeks prior to the SPE start date. View the Blue Card Fact Sheet for further information
- Complete PrePlace and a Student Placement Agreement (further information will be provided by the placement office upon enrolment)
- Be willing to travel to attend supervised professional experience placements
- Visit Education - Professional Experience (PEX) for more information regarding requirements for placements
- *It is no longer a requirement that students in Bachelor of Education/Bachelor of Recreation and Outdoor Environmental Studies are fully vaccinated against COVID-19.*
