1. What is this course about?

1.1. Description

This course is only for students with two teaching areas in the Arts. Learning experiences in this course will extend knowledge and understanding of content in EDU725 Teaching Junior Secondary Arts 1 and enrich your repertoire of pedagogical approaches for this second Arts teaching area and for integration of the Arts. You will undertake observations in school classrooms, critically evaluating how the curriculum is enacted and shaped by the school context. You will design learning experiences and assessment tasks that align with the Australian Curriculum.

GOAL:	The goal of this task is to demonstrate your knowledge and understanding of your Arts discipline, and your capacity to research and evaluate theory and practical application.		
PRODUCT:	Written Piece		
FORMAT:	<p>You are to write and format a feature article suitable for submission to a professional journal or magazine that demonstrates your knowledge of a specific aspect of your Arts discipline. Your audience for this article is teachers of Years 7-10, who may or may not be specialists in the subject. You may adopt an integrated approach, making connections between your second teaching area and another Arts subject. You should consider current curriculum frameworks and policy directives; as well as some or all of the following:</p> <ul style="list-style-type: none"> • the relevance of literacy and numeracy learning activities in The Arts; • the importance of embedding Aboriginal and Torres Strait Islander perspectives in the classroom; • and how ICT can effectively enhance learning in The Arts. <p>You will incorporate references appropriately for an article published in a professional journal utilising APA referencing style.</p>

FORMAT:	<p>This task requires you to undertake approximately 10 hours of classroom observations in a Year 7-10 classroom in your Arts subject. The observation site is to be arranged in discussion with the course coordinator.</p> <p>Based on your observations, you are to report on your observations, and critically question how the Arts curriculum and General Capabilities/Cross-Curriculum Priorities are enacted in the classroom, and how the subject is positioned in the school. A template is available on Canvas.</p>

Late submission of assessment tasks may be penalised at the following maximum rate:

- 5% (of the assessment task's identified value) per day for the first two days from the date identified as the due date for the assessment task.

- 10% (of the assessment task's identified value) for the third day - 20% (of the assessment task's identified value) for the fourth day and subsequent days up to and including seven days from the date identified as the due date for the assessment task.

- A result of zero is awarded for an assessment task submitted after seven days from the date identified as the due date for the assessment task.
