#### **1. What is this course about?**

##### **1.1 Description**

This is an advanced active research course where you will participate and contribute to an innovation project in the field of occupational therapy. You will directly apply in-class learning around innovation and project management to a collaborative practicum project addressing a professional, clinical or practice issue. This will be an exciting space to progress your understanding of evidence, research principles and method.

#### Assessment Task 1: Annotated bibliography

<b>Goal:</b>	The purpose of this task is to immerse you in research in the field of occupational therapy, allowing you to consolidate, synthesise and critique literature relevant to your innovation project.
<b>Product:</b>	Annotated bibliography
<b>Format:</b>	<p>The topic of your annotated bibliography will be negotiated with your group members to ensure an independent and useful investigation.</p> <p>The annotated bibliography should be 2000 words in length.</p> <p>The bibliography will include approximately 5 to 10 sources including a minimum of 5 peer reviewed journal articles.</p> <p>The annotated bibliography should include the following:</p> <p><b>1) Overview</b> (approximately 200 words)</p> <ol style="list-style-type: none"> <li>Introduce your research area and how it informs the overarching group project</li> <li>Identify the specific research question explored in this bibliography</li> </ol> <p><b>2) Citations and annotations</b></p> <p>Provide the full citation (not included in word count) and corresponding annotation below. Arrange the citations in alphabetical order.</p> <p>For each resource write a brief annotation of 100- 150 words. This includes:</p> <ol style="list-style-type: none"> <li>identification of the key concepts and supporting evidence</li> <li>appraisal of quality</li> <li>relevance to the group project</li> </ol> <p>You <b>must NOT</b> directly quote from any text from a source in this assessment task.</p> <p><b>3) Summary</b> (approximately 300 words)</p> <ol style="list-style-type: none"> <li>Confirm the research you are exploring.</li> </ol>

	<p>b) Provide a summary of the key concepts and available evidence and apply these to the overarching group project.</p> <p><b>4) Appendices</b> (not include in word count)</p> <p>a) Appendix A: Reference list using APA 6th referencing style</p> <p>b) Appendix B: A copy of the search strings used to retrieve the papers included in the bibliography</p>

### Assessment Task 2: Innovation Project Poster Presentation

<b>Goal:</b>	The goal of the group poster presentation is for you to communicate your project development to an audience of industry professionals.
<b>Product:</b>	Poster and oral explanation
<b>Format:</b>	<p>Posters can be created in your own choice of digital software/platform.</p> <p><b>Poster size: AO</b>  <b>File type: pdf</b>  <b>Length: Poster - 800 word equivalence. Oral Explanation - approximately 2 minutes</b></p> <p>Your poster should include the following key information:</p> <ol style="list-style-type: none"> <li>Rationale, background literature and/or review of current practice</li> <li>Description of innovation</li> <li>Proposed evaluation methods</li> </ol> <p>Only <b>ONE</b> poster submission per group. Each team member will need to retain a copy of the poster for their own future reference and use in Task 4.</p> <p>Your posters will be displayed for an audience of professionals during an on-campus Honours Conference.</p> <p>The group will need provide a prepared 2-minute verbal synopsis of their project overview of their project and field at least one question related to the project during the poster sessions at the honours conference. An opportunity to present draft posters for peer feedback will be provided in tutorials prior to your final presentation in Week 10.</p>
<b>Criteria:</b>	<p>You will be assessed against the following criteria:</p> <ul style="list-style-type: none"> <li>• Quality of project development and quality of innovation: authentic and realistic, based on background literature and findings, evaluation methods proposed</li> <li>• Communication of innovation (Poster): consolidation and synthesis of project information for presentation in poster format, visual clarity of poster in communicating key project aspects</li> <li>• Communication of innovation (Oral Explanation): clear and accurate oral explanation of project, ability to field questions reflecting detailed knowledge of project</li> </ul>

**Assessment Task 3: Innovation Project Report**

<b>Goal:</b>	This task provides you with the opportunity to develop transferable skills in critical thinking, communication and team work. Additionally, executing and presenting a group innovation project will demonstrate responsibility and autonomy in learning
<b>Product:</b>	Report
<b>Format:</b>	<p>Your project report will include the following sections:</p> <ol style="list-style-type: none"> <li>Executive summary</li> <li>Project rationale and its relevance to occupational therapy</li> <li>Integrated literature review</li> <li>Detailed project innovation description</li> <li>Project outcomes and evaluation methods</li> <li>Project limitations</li> <li>Discussion</li> <li>Conclusion</li> <li>Detailed Gantt chart reporting on project development and projected future plans (if relevant)</li> <li>Proposed budget</li> <li>Acknowledgement of contributions</li> <li>Appendices (if required)</li> </ol> <p>7000 words <b>NOT</b> including tables, figures, acknowledgements, appendices and reference lists. Only <b>ONE</b> project report per group is expected to be submitted. Each team member will need to retain a copy of the report for their own future reference and use in Task 4.</p>
<b>Criteria:</b>	<p>You will be assessed against the following criteria:</p> <ul style="list-style-type: none"> <li>Communication of innovation project, project development and evaluation in a written format, using appropriate terminology to a professional audience.</li> <li>Demonstration of project planning, and responsive execution Synthesis and presentation of data from a range of sources Identification of the limitations of the project and discussion of implications for occupational therapy based on advanced theoretical knowledge.</li> </ul>

**Assessment Task 4: Innovation Project Oral Defence**

<b>Goal:</b>	The goal of this assessment item is to give you an opportunity to communicate an overview of your group innovation project and provide informed responses, generated from your individual participation in this task.
<b>Product:</b>	Oral defence
<b>Format:</b>	<p>Individual oral task of 10 minutes in length (approximately).</p> <p>Some of the key aspects covered will be:</p> <ol style="list-style-type: none"> <li>Detailed explanation of your contribution to the group innovation project</li> <li>Individual responses to question/s about an aspect of your innovation project.</li> </ol> <p>You will have access to your own copy of the group project report and digital poster to refer to throughout your response.</p>
<b>Criteria:</b>	<p>You will be assessed against the following criteria:</p> <ul style="list-style-type: none"> <li>Evidence of individual participation and contribution to overall project process.</li> <li>Evidence of individual participation and contribution to overall project report.</li> <li>Judgement of the relevance and application of the group project to the field of occupational therapy based on group experience and evaluation.</li> <li>Quality of oral communication.</li> <li>Demonstration of understanding of the project by responding to specific question/s through the application of project knowledge.</li> </ul>

### 7.1 Directed study hours

#### Eligibility for Supplementary Assessment

### 10.3 Assessment: Submission penalties
